- Live animals will not be permitted on premises.
- Gunpowder, black powder or any black powder substitute may not be sold or brought onto the premises.
- I and members of my party will abide by all Federal, State, and local laws and regulations governing the sale of firearms, bird, reptile, and animal parts; the "Native American Crafts Act" and the "Native American Graves Protection and Repatriation Act."
