Dear Camping Members:

We hope you have had a wonderful camping season with all of the beautiful weather we have had. Fall is upon us, and we are so thankful for our friends, family and all of our members of the NMLRA. As time does not wait for any of us, it is now time to plan for your upcoming camping reservations.

Enclosed is important information about camping for 2026. The camping rates will remain the same as last year. Upon request from our camping members and to ease the burden of rising costs, the NMLRA has developed a payment plan. The payment schedule is enclosed on page eight of your Campsite Use Agreement, which allows your camping fees to be paid over a six-month time period. If you are participating in the payment schedule your first payment/deposit is due by **December 12, 2025**, as indicated with the last payment being due by **May 12, 2026**. You may also choose to pay the full amount by December 12, 2025, or \$75.00 deposit by December 12, 2025, and the balance by February 28, 2026.

Please keep in mind the following items must be received in the NMLRA office by December 12, 2025, or your campsite may be released for new reservations as of January 1, 2026.

1. **Camping Reservation/Deposit Form** – Please complete all fields and select one of the options provided.
2. **Enclose your deposit of \$75.00** if paying the balance in full by February 28, 2026, **or submit your first payment** with your final payment to be May 12, 2026. If participating in the payment program each payment will be due by the 12th of each month (Jan. – May 2026) for the amount specified in the payment schedule. You may also pay the full amount.
3. **Your signed Campsite Use Agreement - Your Agreement must be filled out on page 1, 2, 3 and 7 to complete all necessary fields.** If you have any questions, please contact us at 812-432-2670.

As a reminder, our check-in procedure **AS PER INDIANA DEPT. OF HEALTH**):

All Members Must Check-In with the NMLRA Camping Coordinator or call before arrival at the Property to obtain a camping ticket and to receive any pertinent site information. Check-In time is 12:00 p.m. (noon) or later and Check-Out time is 11:00 a.m. after the last paid night.
